2. You will see pledge options and designation options. The first 2 pledge options give you the opportunity to increase your giving by a percent or dollar amount. Other options are pledge as last year, change the amounts for charities given to last year, or create a new pledge. Additionally, designation options allow you give to the general fund, allow your increase to go to the general fund or allow your increase to be spread among your current designations.
3. If a completely new pledge is requested, select the radial button “I would like to enter a new pledge this year” and click NEXT. A similar screen below will display.

4. If an employee did NOT contribute in the previous year or if a charity is not participating in this year’s campaign, the above will display.
5. Under the section called “Please Select You Pledge Type,” select the Payroll Deduction option so that the box is highlighted blue. This option allows you to give an amount from each pay period over the next calendar year; there are a total of 26 pay periods.
6. You can either enter the amount you want deducted from each pay period or the total annual amount. In this example, the employee wants to give an annual amount of \$100.00. This option allows you to give an amount from each pay period over the next calendar year; there are a total of 26 pay periods for active state employees and 12 pay periods for pensioners.

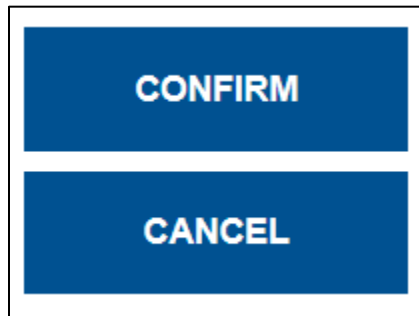

12. To receive an email confirmation with your pledge information, enter your email address and select to first option, “I want the system to automatically e-mail my confirmation receipt to me.”
13. To receive acknowledgement from the organizations you designated to support, select the second option, “I wish to be acknowledged by my designated charitable organizations. I have authorized release of my e-Mail for the purpose.” And/or the third option, “I wish to release my name to my designated charitable organization.”



14. Select Confirm to complete your payroll deduction pledge.
